Important Questions	Answers	Why This Matters:
What is the overall <u>deductible</u>?	For <u>network providers</u> \$1,000 individual or \$3,000 family; for <u>out-of-network providers</u> \$3,000 individual or \$9,000 family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. <u>Preventive Care</u> and <u>Wellness</u> are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain <u>preventive services</u> without <u>cost-sharing</u> and before you meet your <u>deductible</u> . Are there other <u>deductibles</u> for specific services?	Yes. \$500 for <u>prescription drug coverage</u> and \$50 for pediatric dental. There are no other specific <u>deductibles</u> . What is the <u>out-of-pocket limit</u> for this <u>plan</u>?	For <u>network providers</u> \$9,100 individual / \$18,200 family; for <u>out-of-network providers</u> \$27,300 individual / \$54,600 family.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.
What is not included in the <u>out-of-pocket limit</u>?	<u>Premiums</u> , <u>Balance Billing</u> Charges, and Health Care this <u>plan</u> doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .

Does this plan provide Minimum Essential Coverage? **Yes**

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
