What is the overall <u>deductible</u> ? Are there services covered before you meet your <u>deductible?</u>	Yes. <u>Preventive Care</u> and Wellness are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes
