If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . |
| Are there services covered before you meet your deductible? | Yes. <u>Preventive Care</u> and <u>Wellness</u> are covered before you meet your <u>deductible</u> . | This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . | What is not included in the out-of-pocket limit? | <u>Premiums</u> , <u>Balance Billing</u> Charges, and <u>Health Care</u> this <u>plan</u> doesn't cover. | Even though you pay these expenses, they don't count toward the out-of-pocket limit . |

Does this plan provide Minimum Essential Coverage? **Yes**
